Grandfathering Arrangement for Incumbent qualified QASRS Trainers

Under the New Arrangement for Qualified Trainers under Quality Assurance System for Recognition Scheme ("QASRS") starting from 1 July 2021, all incumbent qualified QASRS trainers ("the incumbent trainers") recognised by the Security Services Training Board ("SSTB") would be grandfathered and they are allowed to teach the QASRS training programme, which covers the whole syllabus of the "Specifications of Competency Standards UoC 107753L1 – Perform basic guarding services for QASRS" under the Qualifications Framework. Incumbent trainers can collect a letter from the SSTB/PEAK starting <u>from May 2021</u>. The letter served as proof that the letter holders are the incumbent trainers recognised by the SSTB.

Letter Collection Procedures

- 1) Incumbent qualified trainer should complete the Letter Collection Application Form (attached at **Annex 1**) which is also available at PEAK reception counter;

- 3) The incumbent qualified trainer will be contacted via mobile phone for data verification and to schedule an appointment for collecting the letter **in person**.
- 4) The incumbent qualified trainer should produce valid Hong Kong identity card / other proof of identify at PEAK reception counter when collecting the letter on the scheduled appointment date.

- Appointment is required for letter collection. Walk-in application will not be entertained.
- Applicant must check all details in the letter carefully.
- The personal data provided will be used for the purpose relating to the letter collection of incumbent qualified trainer.
