Before registration, candidates should ensure that they: (a) have read the Examination Rules for Pleasure Vessel Operator Certificate of Competency (“the Examination Rules”) of the Marine Department (“MD”) and the Examination Handbook of the PEAK Exam Centre and satisfy all the eligibility criteria for Pleasure Vessel Operator Examination and Certification, including all documentary proof required and stipulated therein; and (b) observe the Examination Rules of the MD and the Regulations of the Examination at Appendix I of the Examination Handbook of the PEAK Exam Centre. Otherwise, they will not be allowed to take the examination for a period as may be decided by the MD or the PEAK Exam Centre.</p> <p>3. A candidate applying for the Pleasure Vessel Operator Grade 2 Certificate (“PVOC2”) must: (a) be at least 18 years of age when applying for an examination; (b) have passed both PVOC2 Part A and Part B of the examination within two years; (c) have attained the required eyesight standards and medically fit for operating a local vessel; (d) satisfy all the requirements stipulated under section 3.1 of the Examination Rules of the MD; and (e) do not suffer from any physical handicap; or have declared and assessed by the MD as stipulated under section 5.10 of the Examination Rules.</p> <p>Note: Details concerning the examination and certification requirement may be found on the MD website at <a href="http://www.mardep.gov.hk">www.mardep.gov.hk</a> and the Examination Rules may be downloaded at <a href="https://www.mardep.gov.hk/filemanager/en/share/pub-services/pdf/examrules_ploc.pdf">https://www.mardep.gov.hk/filemanager/en/share/pub-services/pdf/examrules_ploc.pdf</a>. Candidates should not register for this examination if they are in the prohibition period that they: (a) are not allowed to sit the examination by the MD or the PEAK Exam Centre; or (b) contravened any misbehavior during the examination and are prohibited from sitting the examination for a period of 12 months from the date of examination for an initial breach and 24 months from the last contravention for further breaches.</p> <p>Candidates should ensure that they are not being prohibited from sitting for re-examination before registration.
