### Handbook for <u>Insurance Intermediaries Qualifying Examination</u> <u>(Remote Invigilation Mode Examination)</u>

#### 1. Introduction

- 1.1 Every individual licensee <sup>1</sup> must have passed the Insurance Intermediaries Qualifying Examination (the Examination), unless otherwise exempted.
- 1.2 Vocational Training Council (VTC) has been appointed by the Insurance Authority (IA) as the examination body. This is administered under an independent unit within the VTC, the Institute of Professional Education And Knowledge Examination Centre (PEAK Examination Centre).
- 1.3 This Handbook aims to inform candidates the requirements and enrolment procedures for Remote Invigilation Mode Examination (RIME) for Paper I, II and III. To assist candidates in preparing for taking RIME, its format, structure and assessment are also described in details. For the examination in Pencil-and-Paper Mode Examination (PPME) and Computer Screen Mode Examination (CSME) for all papers, please refer to the respective Handbook of the Examination for details.

#### 2. Examination

#### 2.1 Structure and Syllabus of the Examination

2.1.1 The Examination consists of the following papers:-

Paper I	:	Principles and Practice of Insurance
Paper II	:	General Insurance
Paper III	:	Long Term Insurance
Paper V	:	Investment-linked Long Term Insurance
Paper VI	:	Travel Insurance Agents Examination (for details, please refer to the Examination Handbook separately published for this paper)

2.1.2 Paper I is a compulsory paper. Papers II, III and V are three optional papers on general insurance, long term insurance and investment-linked long term insurance respectively.

- 2.1.4 Syllabuses for Papers I, II, III and V can be downloaded from the websites of the PEAK Examination Centre and the IA which at <u>www.vtc.edu.hk/cpdc</u> and <u>www.ia.org.hk</u> respectively.
- 2.1.5 <u>The RIME is available for Paper I, II and III only.</u>
- 2.1.6 Candidate who passes the relevant RIME papers would be considered, for the purposes of licensing, as having passed the equivalent IIQE papers, such that he/she can be granted an intermediary licence by the IA to carry on regulated activities in the lines of business that passing these papers would permit, subject to the fulfillment of all other applicable licensing requirements. However, within 18 months<sup>2</sup> counting from the date of passing the RIME paper ("the 18-month period"), the individual must also:
  - 1. attend a tailor-made course to be administered by VTC for the relevant IIQE paper (a certain number of CPD hours will be available for such course, please refer to the website of PEAK at <u>www.peak.edu.hk/en</u> for details); or
  - 2. pass the relevant original IIQE paper.

or otherwise, his/her licence will expire upon the expiry of the 18-month period.

#### 2.2 Format of the Examination

- 2.2.1 Paper I lasts for 2 hours and consists of 75 multiple-choice questions. Paper II and III each lasts for 1 hour 15 minutes and consists of 50 multiplechoice questions.
- 2.2.2 Each examination paper is presented in either English or Chinese. Candidates should choose to take the examination in either English or Chinese when they enrol for the examination. Candidates may apply for changing the language of examination paper chosen in writing by providing their contact telephone numbers, examination date and time, and a copy of Hong Kong Identity Card or Passport, and sending email to <u>cpdc@vtc.edu.hk</u> at least 5 working days before the examination. candidates submit the application for changing the language of examination paper more than once, only the first application received by the PEAK Examination Centre will be processed.

- 2.2.3 All examination questions are compulsory.
- 2.2.4 Candidates taking the RIME are required to take the examination at home or at private location of their choice. The examination venue chosen must be able to comply with the examination environment requirements set out in section 4 of this Handbook.
- 2.2.5 Invigilator will monitor and observe the candidates' behaviors in real-time through camera, microphone and speaker throughout the examination session. The entire session will also be recorded for assessment of any irregularities during the RIME.
- 2.2.6 Candidates should familiarize themselves with the examination process, device requirements and setting, and installation and operation of the Examination System Client of the RIME well beforehand by reading the Examination Process, Device Requirements and Setting, and System Operations at Appendix I and Admission Email Sample at Appendix II. The VTC and/or PEAK Examination Centre will not be responsible for any disputes and consequences resulting from commands incorrectly inputted by the candidates or candidates' failure to log in the Online Examination System (Examination System) and/or to turn on the Eagle-Eye monitoring due to their lack of understanding of the operations of the RIME.

#### 2.3 Grading and Results

- 2.3.1 Examination results are graded as follows:-
  - (i) **PASS**
  - (ii) FAIL

The exact score, the examination questions and the corresponding correct answers will not be disclosed in any case.

2.3.2 Candidates who are not able to log in the Examination System and/or to turn on the Eagle-Eye monitoring within 15 minutes of the designated start time of the examination for whatever reasons are regarded as "ABSENT". Absentees will not be re-scheduled to another examination session and the fees paid are not refundable or transferable.

#### 2.4 Assessment

To pass the examination of each paper, candidates are required to attain a minimum score of 70%.

#### **3.** Device Requirements

- 3.1 Candidates are required to use **<u>TWO</u>** devices for the examination:
  - Examination Device: <u>one</u> PC or laptop computer equipped with a camera, microphone and speaker, and capable of downloading and installing Examination System Client to log in the Examination System for the

examination; and

- Eagle-Eye Monitoring Device: <u>one</u> smartphone or tablet equipped with a camera, microphone and speaker, and capable of scanning QR code; scan the QR code on screen of the Examination Device for real-time Eagle-Eye monitoring after the device has been logged in the Examination System.
- 3.2 Before enroling for the examination, candidates must make sure that they have the appropriate equipment, properly installed the Examination System Client and checked the Examination Device, and that they have a stable and uninterrupted internet connection with a good speed to support the connection of both the Examination Device and Eagle-Eye Monitoring Device at the same time. The above equipment should be checked again at least 30 minutes before the examination.
- 3.3 Candidates should ensure they are capable of taking RIME prior to enrolment. PEAK Examination Centre will not provide technical support and is not liable for candidates' operations, equipment or internet connection being at fault. Candidates who are unable to complete the examination due to failure of the Examination Device, Eagle-Eye Monitoring Device or the internet connection, or who leave the Examination System after logging in, will not be given extra time or allowed to login again.
- 3.4 Candidates should read Appendix I carefully to understand the examination process, device requirements and setting, installation and operation of the Examination System of the RIME. Candidates are required to meet the relevant device requirements, otherwise they may be unable to log in the Examination System and/or to turn on the Eagle-Eye monitoring, and are regarded as "ABSENT" as a result.

#### 4. Environment Requirements

- 4.1 Candidates taking the RIME must be alone throughout the examination session in a quiet and well-lit private room that is invisible from the outside and is able to preclude someone from walking into the room during the examination; noise from the outside should be effectively blocked out so that the candidates can take the examination without disturbances or interruptions.
- 4.2 Candidates must sit at a clean desk. The desk and walls around the candidates must not have any writing.
- 4.3 Candidates may be asked to perform a 360-degree scan of the room (Room Scan) by using the Eagle-Eye Monitoring Device in the course of the examination if considered necessary by the invigilator.
- 4.4 If candidates fail to provide a quiet and secure environment to take the examination, or to follow the invigilator's instructions to perform the Room Scan, they will be regarded as violating the examination regulations and the PEAK Examination Centre reserves the right to withhold the examination results or disqualify the candidates for that examination session.

#### 5. Application

5.1 The RIME is open to applicants who are <u>not</u> existing licensees but wish to be licensed by the IA. The PEAK Examination Centre has no obligation to verify and/or inform candidates whether they are applicable to be licensed through the RIME.

- 5.2 All enrolments of the examination can only be made online at the Online Enrolment System (www.vtc.edu.hk/cpdc/econline).
- 5.3 Applicants may enrol for more than one paper of the examination, but not more than one session of the same papers within the same month.
- 5.4 All examination seats are allocated on a **first-come-first-served** basis. Incomplete online enrolment applications and application received without payment will not be processed.
- 5.5 Nevertheless, subject to the agreement of applicants, they will be arranged to sit for an examination session which differs from their original choices if the examination sessions chosen are already full. The PEAK Examination Centre reserves the right to allocate applicants to designated examination sessions.
- 5.6 Once the enrolment is accepted, any requests for re-scheduling and/or cancellation will not be entertained. Fees paid are not refundable or transferrable.

#### 6. Enrolment Procedures

- 6.1 Applicants should ensure that they meet the device and environment requirements before making enrolments for the RIME. Otherwise, they may not be able to run the examination successfully and are regarded as "ABSENT". Absentees will not be re-scheduled to another examination session and the fees paid are not refundable or transferable.
- 6.2 Applicants should select the examination session(s) and provide personal particulars in the Online Enrolment System. The personal particulars provided should be accurate and the same as those printed on the Hong Kong Identity Card or Passport. If there is any discrepancy in the particulars, candidates will not be able to log in the Examination System and to turn on the Eagle-Eye monitoring.
- 6.3 Applicants should pay the examination fee by Visa, Master or UnionPay Card in the Online Enrolment System.
- 6.4 Online enrolment process should be completed within 20 minutes. Otherwise, the selected examination session(s) will be released and the enrolment process has to start all over again.
- 6.5 If the enrolment is accepted, an Admission Email will be sent to the email address provided by the applicants at least 3 full working days before the date of the examination concerned. If the enrolment is not accepted, applicants will receive a notification from the PEAK Examination Centre by phone or by email not later than 5 full working days of the enrolment, excluding the date of enrolment, and the fees paid will be refunded.
- 6.6 For the operations of the Online Enrolment System, please refer to the Online Enrolment Instructions at <u>www.vtc.edu.hk/cpdc/econline</u>.

#### 7. Payment of Examination Fee

7.1 Examination Fee

- 7.2 Payment can only be made in the Online Enrolment System by Visa, Master or UnionPay Card. Receipt will be issued to the applicant by email after the completion of payment.
- 7.3 Entry to the examination will be invalidated if a candidate fails to comply with the above-mentioned payment procedure.
- 7.4 Fees paid are **not refundable or transferable** except where the candidates cannot be arranged to sit for one of their chosen examination sessions.
- 7.5 Fees may be subject to revision as required.

#### 8. Admission Email

- 8.1 The Admission Email (see Appendix II for the sample) contains the following information:
  - RIME Paper, Examination Date and Time;
  - Test Code and Ticket Number to log in the Examination System;
  - URL to download the Examination System Client; and
  - Notes to examination.
- 8.2 Candidates should notify the PEAK Examination Centre if they do not receive Admission Email 2 working days before the examination. Candidates should also notify the PEAK Examination Centre by email to cpdc@vtc.edu.hk at least 2 working days before the examination if amendments in the personal particulars are required.
- 8.3 Candidates will **not** be able to log in the Examination System and will be regarded as "ABSENT" if there is a lack of Admission Email or incorrect personal particulars. Absentees will not be re-scheduled to another examination session and the fees paid are not refundable or transferable.

#### 9. Computer or System Breakdown

Candidates' results will be invalid if there is a technical breakdown in the Examination System and/or Eagle-Eye monitoring caused by whatever reason during the examination. The PEAK Examination Centre will try to fix the problems but delay may inevitably arise. If the technical problems cannot be fixed within a reasonable time, the PEAK Examination Centre will arrange the candidates concerned to take a rescheduled examination as soon as possible. Candidates cannot object to the arrangements and any requests for cancellation and/or refunds will not be entertained. The VTC and/or PEAK Examination Centre will not be liable for the candidates' losses resulting from the system breakdowns.

#### **10. Examination Regulations**

Candidates should read carefully the Regulations of the RIME at Appendix III. Candidates who fail to observe any of these regulations may be disqualified from taking the Examination for up to 3 years and may be prosecuted.

#### 11. Disqualification

- 11.1 If a candidate is found to have breached the Regulations of the RIME (see Appendix III) in the examination, he/she may be disqualified from taking all the papers of the Examination for up to 3 years. The PEAK Examination Centre would report to the IA any disqualification cases in respect of the Examination.
- 11.2 Any candidates who deliberately attempt to, or intend to disrupt the system operations will be disqualified immediately and are required to indemnify VTC for the losses. The PEAK Examination Centre would also report the incident to the IA.
- 11.3 The PEAK Examination Centre would report to the Hong Kong Police Force, and/or any law enforcement bodies if candidates commit any illegal acts during the examination.

#### 12. Identification Requirements

- 12.1 Candidates are required to follow the instructions on screen to capture their appearance, front and back of their valid and original Hong Kong Identity Card or Passport for identification checking after logging in the Examination System. The identification document must be the original of the one registered for the enrolment. Those who fail to produce such documents for verification of identity, whose identification documents are invalid, or whose identity cannot be satisfactorily verified will not be permitted to sit for the RIME. Fees paid are not refundable or transferable.
- 12.2 Candidates will be allowed to start the examination at designated examination start time after their identity has been verified successfully.

#### **13. Distribution of Results**

- 13.1 Provisional examination result will be shown on the screen of the Examination Device immediately after completion of the RIME. The provisional examination result is for reference only and is subject to the result printed on the Notification of Result.
- 13.2 Candidates can download and print the Notification of Result in the "Exam Result Checking" system on the website of the PEAK Examination Centre (www.vtc.edu.hk/cpdc) starting from the 3rd full working day after the date of examination. The examination results will be available in the system for 3 months counting from the respective date of examinations. After 3 months of the examinations, candidates are required to apply for re-issuance of the Notifications of Results (please refer to 13.7.1).
- 13.3 Candidates who do not agree to having their results and Notifications of Results available in the "Exam Result Checking" system must inform the PEAK Examination Centre in writing by email to cpdc@vtc.edu.hk at least 3 full working days before the date of examination. Candidates should provide their name, Hong Kong Identity Card or Passport number, date of examination, name of examination paper and contact telephone number in the email. Late notifications will not be entertained. Their Notifications of Results will then be sent to the candidates' email address within 7 full working days after the dates of examination. If the Notification of Result was lost in the email, candidates are required to apply for re-issuance.

- 13.4 By virtue of confidentiality, the PEAK Examination Centre will not disclose the examination results by phone or facsimile.
- 13.5 If any irregularities are found during the examination, the Notification of Result will be withheld until further notice.
- 13.6 List of candidates who passed the Examination (including Hong Kong Identity Card number or Passport number) may be sent to the IA for reference.
- 13.7 Re-issuance of Notification of Result
  - 13.7.1 Candidates may request a re-issued copy of the Notification of Result in writing together with their contact telephone number, email address and a copy of the Hong Kong Identity Card or Passport to the PEAK Examination Centre by email after 3 months of the examination. The application for the re-issuance of copy is free of charge. Re-issued copy of the Notification of Results will be sent to candidates by email 7 working days after receipt of the application (excluding the application date).

#### 14. Re-marking of the Examination Papers

- 14.1 Candidates who are not satisfied with their examination results may, within2 weeks after the issuance date of the Notification of Result, request in writing to the PEAK Examination Centre for re-marking of the examination papers.
- 14.2 Candidates submitting such request would have to enclose a crossed cheque or cashier's order for HK\$400 payable to "Vocational Training Council" as a fee for re-marking of each examination paper.
- 14.3 All re-marking fees are non-transferable and non-refundable. However, if the original examination result is found incorrect after the re-marking, the re-marking fee will be refunded to the candidate concerned.
- 14.4 All re-marking applications will be kept confidential.
- 14.5 The result will be sent to the candidates concerned in writing within one month of the receipt of the re-marking request.
- 14.6 Candidates will only be notified of the final grading (i.e. PASS or FAIL). The result of the re-marking is final. The PEAK Examination Centre will not disclose the exact scores, the examination questions and the corresponding correct answers in any case.

#### 15. Re-issuance of Receipt

- 15.1 Candidates may request a re-issued copy of the receipt in writing or in person providing their contact telephone numbers, a copy of the Hong Kong Identity Card or Passport, information on re-issued receipt, and postal address if returned by mail. The charge is HK\$10 per receipt.
- 15.2 For postal application, candidates should enclose a crossed cheque or cashier's order for the proper amount of re-issuance fee payable to "Vocational Training Council".

- 15.3 The PEAK Examination Centre will contact the candidates by phone to collect the re-issued copy of the receipt in person 7 working days after the receipt of the application (excluding the application date). Alternatively, the re-issued copy of the receipt can be sent to candidates by post. The PEAK Examination Centre will not be responsible for the loss of the re-issued copy of receipt sent by post.
- 15.4 The uncollected re-issued receipt(s) will be disposed of one year after the application date.

#### **16. Study Notes for Examination**

- 16.1 The Study Notes for the Examination can be downloaded from the websites of the PEAK Examination Centre and the IA which at <u>www.vtc.edu.hk/cpdc</u> and <u>www.ia.org.hk</u> respectively. Candidates may also request for a hard copy of the study notes at the PEAK Examination Centre. A copying charge of HK\$50 by cash will be collected for each copy of study notes requested. PEAK Examination Centre would not be responsible for any disputes in cases where the Study Notes run out of stock. Copying charges paid are **not refundable**.
- 16.2 The PEAK Examination Centre will only exchange the sold Study Note for once if there is any failure in printing or binding (e.g. missing page). Candidates have to present the Study Note and original receipt at the PEAK Examination Centre within 7 calendar days of the date of purchase for exchange.

#### 17. Notice on Personal Data (Privacy) Ordinance

- 17.1 Candidates are advised to read the notice relating to the Personal Data (Privacy) Ordinance at Appendix IV in understanding their rights and obligations regarding the supply of their personal data to the VTC and/or PEAK Examination Centre and the manner in which the VTC and/or PEAK Examination Centre may use or deal with such data for their examination applications.
- 17.2 Candidates who apply to sit for the Examination should read the Notes on Personal Information Collection in Connection with the Insurance Intermediaries Qualifying Examination and confirm the Consent in the Online Enrolment System when they enrol for the examination.
- 17.3 Candidates' appearance and their identification document will be captured to verify their identification. The entire examination session will be recorded to assess any irregularities during the examination. Candidates must give their consents to the PEAK Examination Centre and the RIME service provider(s) for being captured and recorded when they enrol for the RIME.
- 17.4 PEAK Examination Centre will keep the photos and videos confidential. Nevertheless, during its operations, the PEAK Examination Centre may, as permitted by law, compare, match, transfer or exchange their data with the data already possessed, or obtained hereafter, by the PEAK Examination Centre for these or any other purposes. The photos captured and videos recorded in the examination will be destroyed two months after the date of the examination concerned.

#### Examination Process, Device Requirements and Setting, and System Operations of Insurance Intermediaries Qualifying Examination (Remote Invigilation Mode Examination (RIME))

Examination and monitoring of the RIME are carried out through the client of "Eztest Lockdown Browser" (Eztest Client). Candidates are required to meet the relevant technical requirements and install the required software, otherwise they may be unable to log in the Online Examination System and/or to turn on the Eagle-Eye monitoring and will be regarded as "ABSENT" as a result. Absentees will not be re-scheduled to another examination session and the fees paid are not refundable or transferable.

#### 1. General Examination Flow



#### 2. Device Requirements

- 2.1 Examination Device
  - 2.1.1 **one PC** or **laptop computer** equipped with a camera, microphone and speaker, and capable of downloading and installing Examination System Client to log in the Online Examination System (Examination System) for the examination.
  - 2.1.2 The recommended configuration of Examination Device is as follows:

Voice:	Speaker and Mic

- 2.1.3 Examination System Client:
  - Examination and monitoring of the RIME are carried out through the client of "Eztest Lockdown Browser" (Eztest Client). Candidates are required to download and install the Eztest Client on the Examination Device, and check the device before examination. The Eztest Client can be downloaded at <u>eztest.org/home/entry</u>.
  - The Eztest Client does not support tablet or mobile devices.
- 2.1.4 Before entering the Examination System, candidates should close all nonexamination related webpages and software on the Examination Device, including but not limited to various communication software, to avoid being regarded as cheating by the system due to passive pop-up windows.
- 2.1.5 No additional monitor is allowed during examination.
- 2.2 Eagle-Eye Monitoring Device
  - 2.2.1 <u>one</u> smartphone or tablet equipped with a camera, microphone and speaker, and capable of scanning QR code for real-time Eagle-Eye monitoring.
  - 2.2.2 The recommended configuration of Eagle-Eye Monitoring Device is as follows:

2.2.3 Before entering the Examination System, candidates should close all nonexamination related applications on the Eagle-Eye Monitoring Device, including but not limited to instant messaging applications or other applications that may interrupt the monitoring process, and to avert incoming calls, alarms or messages, etc., to avoid being disqualified from the examination.

- 2.2.4 After the Examination Device has been logged in the Examination System, candidates should use the Eagle-Eye Monitoring Device to scan the QR code on the screen of the Examination Device for real-time Eagle-Eye monitoring.
- 2.3 Network Requirement
  - 2.3.1 Candidates should have a stable internet connection to support the connection of both the Examination Device and Eagle-Eye Monitoring Device at the same time.
  - 2.3.2 The network bandwidth should not be less than 20Mbps. A separate fiber optic network with a bandwidth of 50Mbps or above is recommended, and upload speed of not less than 2MB/s.
- 2.4 Candidates are required to meet the relevant device requirements and to check the Examination Device before examination, otherwise they may be unable to log in the Examination System and/or to turn on the Eagle-Eye monitoring, and are regarded as "ABSENT" as a result.

#### 3. Device Setup

3.1 The setup of Examination Device and Eagle-Eye Monitoring Device is recommended as follows:

  - 4.1 Eztest Lockdown Browser

#### **General Rules**

- 1. Candidates must comply with all rules, regulations and requirements set forth in this Examination Handbook. Those who fail to comply will be disqualified from the Examination.
- 2. Candidates must take RIME session according to the date and time as stated in the Admission Email.
- 3. Candidates must prepare all required materials before the start of the examination, including Hong Kong Identity Card or Passport, Examination Device, Eagle-Eye Monitoring Device and make sure that they do not take a toilet break during the RIME. Candidates are not allowed to leave the room used for taking the RIME, and they must be present in front of the cameras and can be seen clearly by the invigilator at all times during the RIME.
- 4. Candidates should re-check and ensure that they have the appropriate equipment, good internet connectivity speed, and properly installed the required software **at least 30 minutes before the designated examination start time**. Candidates who are not able to log in the Online Examination System (Examination System) and/or to turn on the Eagle-Eye monitoring successfully are regarded as "ABSENT". Absentees will not be re-scheduled to another examination session and the fees paid are not refundable or transferable.
- 5. 30 minutes before the designated examination start time, candidates shall be allowed to (a) input the test code and ticket number as stated in the Admission Email at the Examination Device to log in the Examination System; and (b) use the Eagle-Eye Monitoring Device to scan the QR on screen of the Examination Device to turn on the Eagle-Eye monitoring. Candidates must also check the cameras angle before the RIME to ensure that (a) the Examination Device can capture the frontal faces of the candidate clearly during the RIME; and (b) the Eagle-Eye Monitoring Device can capture the candidate's head, shoulders, hands, Examination Device screen and the surrounding environment from the left/right side of the Examination Device.

- 20. If candidates encounter any problems during the RIME, they can click "Monitor" in the function area at the upper right of the Examination Device screen and enter text to seek assistance from the invigilator. The invigilator will provide assistances through the chat room or video call. However, technical support will not be provided.
- 21. At the end of the RIME, candidates can view the provisional examination result immediately and real-time monitoring and recording of the Examination and Eagle-Eye Monitoring Devices will be terminated.

#### Disqualification

A candidate may be disqualified from the Examination for up to 3 years, if he/she:

- 17. does not turn off his/her electronic devices including the alarm function and/or emits sound rings during the RIME;
- 18. does not turn off the functions and applications in the Eagle-Eye Monitoring Device including instant messaging application, etc.
- 19. opens any browsers, applications or files, etc. other than the Examination System Client in the Examination Device for whatever reason during the RIME;
- 20. fails to follow any of the General Rules or the instructions of the invigilators in the course of the RIME; or
- 21. misbehaves or acts dishonestly during the RIME.

#### **Proof of Identity**

- 1. If the Pre-No. 8 Special Announcement / Typhoon Signal No. 8 or above / Black Rainstorm Warning Signal / "Extreme Conditions" is issued / in force after 6:15 a.m., but before 11:00 a.m., examinations between 9:00 a.m. to 12:00 noon will be cancelled.
- 2. If the Pre-No. 8 Special Announcement / Typhoon Signal No. 8 or above / Black Rainstorm Warning Signal / "Extreme Conditions" is issued / in force at 11:00 a.m., but before 4:00 p.m., examinations between 12:00 noon to 6:00 p.m. will be cancelled.
- 3. If the Pre-No. 8 Special Announcement / Typhoon Signal No. 8 or above / Black Rainstorm Warning Signal / "Extreme Conditions" is issued / in force at or after 4:00 p.m., examinations between 6:00 p.m. to 10:00 p.m. will be cancelled.
- 4. Candidates are advised to visit the PEAK Examination Centre website (<u>www.vtc.edu.hk/cpdc</u>) for any special announcements concerning postponement of examinations. The candidates will be notified of the new examination date and time as soon as possible.
- 5. However, once the examination has commenced, candidates are required to sit through the examination even if the Typhoon Signal No. 8 or above or the Black Rainstorm Warning Signal is announced.

#### Notice relating to the Personal Data (Privacy) Ordinance

In view of the Personal Data (Privacy) Ordinance ("the Ordinance"), this notice is to help candidates understand their obligations and rights in respect of the supply of their personal data to the Vocational Training Council (VTC)/PEAK Examination Centre and the way in which the VTC/PEAK Examination Centre may use or handle such data.

- (1) Candidates are required to keep the VTC/PEAK Examination Centre informed of any change of their personal data once they are enrolled as candidates for the examination until 6 months after the date of the examination.
- (2) The VTC/PEAK Examination Centre may use the supplied personal data for the following purposes:
  - a. administering the examination;
  - b. providing personal data of candidates to the relevant RIME service providers to run the examination;
  - c. maintaining a candidate record;
  - d. distribution of examination results to candidates concerned;
  - e. posting of examination result on the website of the PEAK Examination Centre for the candidates' own checking and downloading, unless expressly requested not to do so by the respective candidate in writing;
  - f. certifying candidates' examination results to the IA;
  - g. reporting cases of disqualified candidates to the relevant regulators and bodies;
  - h. research or statistical analysis; or
  - i. any other related purposes.
- (3) The VTC/PEAK Examination Centre will keep the personal data of candidates confidential. Nevertheless, during its operations, the VTC/PEAK Examination Centre may, as permitted by law, compare, match, transfer or exchange their data with the data already possessed, or obtained hereafter, by the VTC/PEAK Examination Centre for these or any other purposes.
- (4) Candidates may have the right under the Ordinance to request access to or correction of any data provided by them as per the manner and limitations prescribed therein.
- (5) As the Ordinance allows, the VTC/PEAK Examination Centre has the right to charge a reasonable fee for the processing of any request for data access.
