- 2. The completed enrolment form should be submitted to the Examination Centre on or before the deadline for enrolment. Late submission will **NOT** be accepted.
- 3. **Different Enrolment Methods** and **Deadline for Enrolment** –

(b) Enrolment by online and in person or by a representative	2 weeks before the date of examination		

- 4. Incomplete forms, forms without applicants' signature and forms received without payment will not be processed.
- 5. **Examination Fee** HK\$700 for each examination paper.
- 6. Once the enrolment is accepted, any requests for re-scheduling and/or cancellation will not be entertained. Fees paid are not refundable or transferrable.
- 7. **Examination Results** Notifications of Result will be sent to candidates by post within **15 full working days** after the date of examination.
- 8. **Certificates -** Candidates who have passed both Paper 1 and 2 of the Leveraged Foreign Exchange Trader's Representative Examination or both Paper 1 and 2 of the Leveraged Foreign Exchange Trader's Responsible Officer Examination within three years will be awarded certificates.
- 9. Candidates must notify the Examination Centre any change of address and personal particulars in writing in good time.
