Notes on Personal Information Collection in Connection with the Mandatory Provident Fund Schemes Examination

With the coming into force of Personal Data (Privacy) Ordinance on 20 December 1996, these Notes are prepared to assist you in understanding your rights and obligations in relation to the supply of personal data by you to the Vocational Training Council or Hong Kong Securities and Investment Institute, whichever holds the examination you intend to sit for and the manner in which the examination body concerned may use or deal with such data in connection with the Mandatory Provident Fund Schemes Examination/MPF Intermediaries Examination and other matters. You are strongly advised to read these Notes carefully before you sign the Consent at the foot thereof.

The examination bodies may transfer or transmit the personal data of those candidates who have passed the Mandatory Provident Fund Schemes Examination/MPF Intermediaries Examination to Mandatory Provident Fund Schemes Authority ("MPFA"), Insurance Authority ("IA"), Securities and Futures Commission ("SFC"), Hong Kong Monetary Authority ("HKMA"), Insurance Agents Registration Board ("IARB"), The Hong Kong Confederation of Insurance Brokers ("CIB") and Professional Insurance Brokers Association ("PIBA"). The personal data so transferred or transmitted may be used by these bodies for monitoring purpose and the purposes of assisting them to perform and discharge their functions.

You are entitled under the Personal Data (Privacy) Ordinance to request access to or to request the correction of any data supplied by you, in the manner and subject to the limitations prescribed therein.
