## Professional Diploma in Business Management (PDBM)

### Objectives:

This programme offers a flexible part-time learning route to students who are working in, or intending to enter into financial, marketing and other business services industries. The programme enables the students to acquire both theoretical and practical knowledge in the business management topics in order to:

- enhance their professional and academic knowledge;
- advance to bachelor degree programmes; and
- achieve life-long learning.

### Features:

- **Education for All:** mature candidates, aged 23 or above with at least 2 years' relevant full-time working experience are welcome to apply
- **Provides Pathway to Honours Bachelor Degree:** graduates are eligible to articulate to BSc (Hons) Global Business Management\*, which is co-offered by Northumbria University, Newcastle and SHAPE.
- **Part-time Evening Delivery:** modules delivered after office hours
- **Flexible Modular Structure:** 8 modules of 30 lecture hours each. Students are free to choose the modules taken each intake
- **Comprehensive Delivery:** all classes are taught by well-experienced practicing professionals

\*All candidates must be able to demonstrate competence in English Language equivalent to an HKCEE pass in English Language (Grade E) or Level 2 in HKDSE English Language, and have 3 years relevant full-time working experience. Additionally, all candidates must complete the two compulsory elective modules, i.e. PBA40003 Human Resources Management and PBA40008 Digital Technologies in Business Management.

### Admission Requirements:

- Five HKDSE subjects at Level 2 or above, including English and Chinese Languages with 2 or more years' relevant full-time work experience; OR
- Five HKCEE subjects at Grade E/Level 2 or above, including English\* and Chinese Languages with 3 or more years' relevant full-time work experience; OR
- Completion of a QF Level 3 programme that is deemed acceptable to the respective Programme Committee; OR
- Relevant Recognition of Prior Learning (RPL) qualification(s) at QF Level 3 or above AND a pass in an admission interview; OR
- Other relevant verifiable prior learning and/or work experience that is/are deemed appropriate by respective Programme Committee AND a pass in an admission interview.

[\* Applicants who took HKCEE English Language in 2006 or before should have attained Grade E or above (Syllabus B) / Grade C or above (Syllabus A)]

[Entry requirements for mature applicants are: Aged 23 years old or above with at least 2 years of relevant full-time work experience subject to a satisfactory admission interview.]

### Mode of Study:

- (1) Face-to-face tutorial 30 hours
- (2) Examination 3 hours 10 sessions for each module, 3 hours per session, total 30 hours at weekday evening.

### Programme Assessment:

- (1) Two assignments (20% each)\* 40 % of total grade
- (2) A 3-hour final examination# 60 % of total grade

- To be eligible to sit for the final examination, students are required to attend at least 70% of the face-to-face tutorials and are required to retake the module if his/her attendance rate is below 70%.
- The overall passing mark (assignments + final examination) of each module is 40%. Students are required to get at least 40% on both assignments and final examination in order to pass a module.
- Satisfactory completion of the programme requires the completion of all modules within 4 years.
- Students who have successfully completed all of the required modules will be awarded the Professional Diploma in Business Management.

#### **Academic Recognition:**

- Northumbria University, Newcastle, UK (<https://www.northumbria.ac.uk/>) – Northumbria University Newcastle Business School is AACSB accredited. PDBM graduates are eligible to enter the final year of the BSc(Hons) Global Business Management\* co-offered by the University of Northumbria at Newcastle and SHAPE. The study location is PEAK.
- \* All candidates must be able to demonstrate competence in English Language equivalent to an HKCEE pass in English Language (Grade E) or Level 2 in HKDSE English Language and have 3 years of relevant full-time working experience. Additionally, all candidates must complete the two compulsory elective modules, i.e. PBA40003 Human Resources Management and PBA40008 Digital Technologies in Business Management. ## Application Procedure

- Please submit your application either by post or by hand to the General Office of the Institute of Professional Education And Knowledge (PEAK) (of the Vocational Training Council) within the application periods stated below.

Office hours: 9:00 a.m. – 7:30 p.m. (Monday to Friday); 9:00 a.m. – 12:00 noon (Saturday)
- Put all documents to be submitted in an envelope marked "**Application for PDBM**".
- We need these documents from you:
  - Completed enrollment form;
  - Reference letter issued by your current employer; and
  - Copies of proof of your academic qualifications, such as transcripts and certificates.
- Incomplete documents or lack of proof of payment required may delay or jeopardise your application.
- Following a successful application, present the original copies of your credentials for verification at the time of registration.
- We offer places to eligible applicants on a first-come, first-served basis.

Please pay course fees by either of these methods:

- Attach a crossed cheque made payable to "Vocational Training Council" to the form submitted by post or in person
- Pay by FPS (For new students, please submit the completed enrollment form and relevant documents at least 18 working days before the commencement date of the module. Current students who intend to settle their tuition fees via FPS are required to submit their completed enrollment forms no less than 14 working days prior to the commencement date of the module. Upon the approval of admission, Programme Secretary will send a Demand Note to students, and notify students with relevant procedures via email. Students should then settle the payment via FPS by scanning the QR code provided in the Demand Note no later than 7 days before the module start date. Students are required to capture and submit payment proof for record-keeping purposes. Failure to provide payment proof may result in delays in confirming enrollment status.)
- Pay in cash or by credit card to the General Office for a confirmed class that commences in 7 working days.

◇ Application period: lasts until it is 7 working days prior to scheduled class commencement.
