Dear PEAK students/candidates,

Precautionary Measures for Prevention of Coronavirus Disease (COVID-19)

You are reminded to be vigilant against COVID-19 and to closely observe the following to prevent its spread:

- 1. You are required to wear a surgical mask when attending class/examination at PEAK and should check your temperature before leaving home and going to teaching/examination venue. If you have a fever, cough, diarrhoea, vomiting or other flu-like symptoms, please seek medical advice immediately and do **not** attend class/examination.
- 2. If you belong to the type of persons who require quarantine or isolation, or subject to compulsory COVID-19 testing in accordance with the prevailing Rules and Regulations announced by the Government of the HKSAR, please do <u>not</u> attend class/examination during the whole compulsory quarantine / testing period, and notify PEAK immediately.
- 3. For students/candidates who are absent from class or examination due to illness, in particular if you are confirmed to have contracted COVID-19, please notify PEAK promptly.

We have implemented a series of precautionary measures against COVID-19 at PEAK, e.g. all staff members are required to have a body temperature check before reporting duties, cleaning and disinfection work at PEAK have been strengthened, and hand sanitizers are provided outside teaching and examination venues. All students and candidates are required to have a body temperature check at the entrance of the VTC Tower, submit a Health Declaration Form to PEAK before entering the teaching/examination venue (applicable for CPD students or candidates) or before lesson via email (applicable to students of award-bearing programmes), wear a self-provided surgical mask on campus, and maintain good personal hygiene. Please strictly follow our Guidelines on Prevention of COVID-19 (**Appendix I**) and submit a completed Health Declaration Form (**Appendix II**) to PEAK before attending class or examination.

We will keep track of the latest development on the spread of the disease. In case there is a need for any special arrangements, announcement will be made through PEAK Website (https://www.peak.edu.hk/en/).

<u>PEAK</u> Guidelines on Prevention of COVID-19

Students and candidates are required to follow the guidelines below:

- Students and candidates are required to complete and submit a Health Declaration Form (Appendix II) to our staff before attending class/examination, indicating that they are not feeling unwell and do not belong to the type of persons who are subject to quarantine, isolation or compulsory testing under the Prevention and Control of Disease Ordinance (Cap. 599). <u>Any false declaration made by the students will be considered as violation of the class/examination regulations and will not be allowed to attend class/examination.</u>
- 2. Students and candidates are required to wear a <u>self-provided</u> surgical mask on campus and use hand sanitizer before entering the teaching/examination venue. <u>Students and candidates who are not</u> <u>wearing a surgical mask will not be allowed to attend class/examination</u>. All students and candidates are required to wear a surgical mask during class/examination. For CPD classes and examinations, students and candidates will be required to take off their masks during the checking of attendance in order to verify their identities.
- 3. Students and candidates who have a fever, cough, diarrhoea, vomiting or other flu-like symptoms should seek medical advice immediately and shall **<u>not</u>** attend class/examination.
- 4. Students and candidates who have been quarantined in a quarantine centre should inform PEAK as soon as possible.
- 5. Students and candidates shall <u>not</u> attend class/examination if they are required to self-quarantine according to the advice of the Department of Health.
- 6. For students and candidates who are required to undergo compulsory COVID-19 testing in accordance with prevailing Rules and Regulations announced by the Government of the HKSAR, they shall **<u>not</u>** attend class/examination during the whole compulsory testing period.
- 7. Students and candidates who cannot attend class/examination owing to (3) or (4) or (5) or (6) above should submit a medical certificate or related supporting documents to PEAK as soon as possible for follow-up arrangements.
- 8. Body temperature check will be taken at the entrance of the campus. A student or candidate whose body temperature exceeds 37.5°C should leave the campus immediately and seek medical consultation.
- 9. Additional provisional measures for infection control may be implemented at the entrance of VTC Tower. Please allow enough time to arrive at the classroom on time.

10. <u>Students or candidates refusing to cooperate will be considered as violation of the class/examination</u> regulations and will not be allowed to attend class/examination.

11. In case classes/examinations are suspended due to the situation of the coronavirus, follow-up arrangements will be notified to the students/candidates by email, SMS or phone.
